As colder weather settles in and a fisher's thoughts turn toward fishing those giant rainbows we call Steelhead. Jack Benoit will tie a pattern called the Steelhead Hammer that works well on these fall beauties. Jack was put onto this pattern by Ken Bowyer who originally read about it in an "Orvis Fishing News" issue several years ago. Ken bought some in chartreuse and red and has had great success with them over the years while steelhead fishing in Ohio and Pennsylvania including our outing 2 years ago to Erie, PA. Your can find a photo of the pattern on the Orvis web site. Type steelhead hammer in the search box. It's basically a black stonefly nymph with a bright color woven through the bottom of the body and an estaz collar. Come to the early segment to learn about and see Jack tie a must have fly for your fall or spring "Steelhead Box".


PPTU MENTOR PROGRAM BEGINNERS & BEYOND

Discussions will include equipment, knots, casting, flies, dry fly and nymphing techniques, entomology, reading water, conservation, etc. at nearby streams. Tackle and Tactic Tips

Waders always seem to leak when you can least afford the time to dry them out and make the repair—or even find a replacement pair if the damage is too extensive. In the past several years a new type of repair material has come upon the scene. This material is a thin gel but when exposed to UV light hardens rapidly into a flexible patch and water seal. Previously, repairs had to wait until the waders were dry, which usually meant that evening. In addition to dry waders, one had to wait many hours (sometimes a full day) for the repair to cure. I have been using an UV-activated repair material made by Loon Outdoors that has performed very well for several years of repairs. I recently discovered that Aquaseal now makes a UV-cure adhesive; I have not tried my first tube yet. This product appears to work the same as the Loon Outdoors wader repair material but requires the wader to be dry, unlike the latter adhesive.

In Alaska this June I dragged a large salmon fly across the rear of my waders only to later discover I had a 1" slit in the whole fabric. The UV-activated repair adhesive fixed the slice in seconds. For indoor repairs one can purchase a tiny UV light that works its magic just as fast as direct sunlight. Usually all that is needed is a very small droplet to seal a leak. The small tube is easily carried in the back of my vest. It is also useful for repairing breathable wading jackets and other materials. I do not leave home without it!

I often chat with fishers in parking lots or shops. Frequently the topic of poachers comes up and I ask them if they called the Natural Resource Police (NRP)? No, left my cell phone in the car....is the usual response. Why? Did not want to get it wet if I fell in. Ok, but have you heard of Ziplock bags? I carry my wallet in a bag, my cell in another, and my FRS radio in still a third, if fishing with a buddy. One time a fishing buddy seemed to be taking a great deal of time to

reply to my initial radioed inquiry as to what the fishing was like near him.

Soon it became apparent that he was trying to pull his radio out of the Ziplock. No need, just press all the buttons and talk right through the plastic bag.

Call the NRP at 1-800-635-6124 to report poachers; better yet, plug it into your cell phone as a speed dial.

A small supply of Ziplock bags resides in my travel kit on any fishing trip. It is not a matter of IF I am going to fall in but WHEN! One never knows when help may be needed. A twisted ankle or worse can make getting back to the car difficult if not impossible. Having a cell phone with you is insurance. Naturally, I leave mine off—I want to hear the gurgle of the water and the birds singing overhead, as well as the slurp of a wary trout back under some bush.

PATUXENT REPORT

DNR expects to have some trout available for fall stockings, but as we go to press we do not have the stocking schedule. Check the DNR web site for the fall stocking reports or watch on the PPCTU list serve. There also will be some electro shocking of some of our local streams. If you are interested in helping stock or shock(!), contact me ASAP (jmsheppar@aol.com).

ANNUAL WARNING: Hunting goes through mid-winter in many sections of Patuxent River State Park, so be careful and stay alert. The firearm season for deer is still a way off, but squirrel hunting starts the first Saturday of October, and dove and archery season for deer will both be continuing as this is mailed. Suggest fishing on weekdays or Sundays; otherwise, wear a bright-colored hat on Saturdays, in particular. Sunday hunting does not apply on state lands, such as the Patuxent River State Park.



If you have moved or see any error in your label on this Conservationist, please advise both the National TU office (1-800-834-2419) and this chapter with separate notices. Our mailing list is maintained apart from the National list; we do eventually get the notice of address change from National TU, but it is often a few months before it affects your Conservationist and other mailings. Please help us help you. Thank you.

Further, please check your membership card from the national TU office after you renew. It is possible that you may have been reassigned to a different chapter unbeknownst to you! Call the above 800-number and ask to be moved to the chapter of your choice and also ask that your record be flagged so as not to be changed at any future time without your requesting the change.

In the past, we have had several reports of members not receiving their Conservationist. First, make sure we have your correct address, including 9-digit ZIP, and that your dues are paid up (label reads PP-0910 until this November, or 0911 after that). If you are missing a back issue, please contact us for a copy. For future reference, we try to mail the Conservationist to our active members about 2 weeks before the next meeting. Remember, we have no mailings or meetings in December or during the summer months of June, July and August.



Annual Supporting Contribution (ASC) now Payable

The \$20 we ask to help support our administrative and printing costs is now payable. We operate on a September to September basis for the chapter's publication, The Conservationist.

Very simply, it costs a lot of money to operate the chapter for meeting room rentals, postage, printing, web site, and other costs. We want to use all the contributions we receive and raise through our fund raisers to support our work for the resource.

If your mailing label reads "PP-0910" (or there is no "PP-" designation) then you need to renew your ASC. You can pay the ASC at the next meeting or just mail it to our chapter mail box. Make checks payable to PPTU. You can choose to have the Conservationist delivered in hard copy or via the Internet; please advise which method you wish and include your email address. You do not have to be a TU member assigned to PPTU to subscribe to the Conservationist by paying the ASC. November will be the last issue for those with "PP-0910" on their label.

TYING FLIES FOR TROUT FOR THE NOVICE OR INTERMEDIATE FLY TYER --

Tying Flies for Trout is designed for the tyer who wishes to learn new tying skills or improve the techniques they already have. The basic skills and materials for tying nymphs, emergers, duns, and spinners, coupled with basic wet fly and streamer construction will be covered. The class focus will be on proven local patterns.

Jim Greco, Carl Smolka, Larry Vawter, Bob Dietz, and possibly Dennis Covert will conduct the class. The class will be at the Schweinhaut Senior Center, 1000 Forest Glen Road, Silver Spring, MD, from 7 to 9 PM on Tuesday nights: January 4, 11, 18, 25 and February 1, 8, 2011.

Tuition for this 6 week class is \$135.00. For TU members who have made a \$20.00 Annual Supporting Contribution (ASC) to PPCTU a discount of \$20.00 applies, making the tuition only \$115.00. The tuition fee covers the room rental, class handouts, and tying materials for flies to be tied in the class with the balance of revenue going to the PPCTU Chapter for use in its education and conservation efforts such as stream restoration, Trout in the Classroom, and Project Healing Waters.

Right now, joining National TU costs only \$17.50, see www.tu.org/intro. Be sure to enter chapter number 236 so PPCTU will get the proper chapter rebate. The introductory offer will also include the PPTU ASC, and entitles you to the \$20.00 discount and other benefits associated with it. Once you join National TU and select PPCTU (#236) as the chapter you wish to be affiliated with, you will be a member of PPCTU. The ASC is optional.
